## C16 HPC Planning Obligations Board – Allocation of CIM Funding

(Report No. WSC 62/16, circulated with the Agenda.)

The purpose of the report was to present the recommendations of the Hinkley Point C Planning Obligations Board for the allocation of monies from the Community Impact Mitigation (CIM) Fund secured through the Section 106 legal agreement for the Site Preparation Works at Hinkley Point.

The Lead Member for Resources and Central Support outlined the details of the report, providing information on the Stogursey and District Victory Hall project and stating that this was one of the most impressive bids received by the Planning Obligations Board (POB). A huge amount of community work had been undertaken and the Lead Member believed this to be a fantastic model to follow; with the community of Stogursey being impacted the most by the Hinkley project.

The reasons for turning down the Somerset Village Agents application were given and the Lead Member reiterated POB's comments that there was a lack of clarity in connection with the impacts on communities in some areas.

The Lead Member proposed the recommendation of the report which were seconded by Councillor C Morgan.

During the discussion, the following points were raised:

- Members were informed that the funding from EDF to the Parish Lengthsman scheme would cease at the end of September 2016 and this would represent a real loss as the Scheme provided a great benefit to Stogursey. The effect of the construction was very disruptive.
- Disappointment was expressed that the Village Agents application had not been not supported.
- The Stogursey Village Hall application should serve as an exemplar to other communities who were seeking to enhance their facilities.
- Confirmation that the Economic Regeneration team had been working on the impacts and effects of the Hinkley build for quite a number of years and the information was readily available.
- Concern that there were not enough projects coming forward to access the CIM Fund.
- Officers were providing guidance and supporting the communities as much as they could with the resources available and once the final investment decision had been made a further campaign would be launched alerting people to the opportunities available and what support was available.
- Members were advised that the recommendations from the Scrutiny Task and Finish Group were being achieved.
- Tribute was paid to Councillors C Morgan and S Goss for their work on the Stogursey project in getting the community together.
- Communities would not fully realise the impacts until the start of the Hinkley project and the number of bids should increase once they were fully known.

**RESOLVED** that the recommendation of the Hinkley C Planning Obligations Board be endorsed as follows:

- (a) To note that Stogursey Parish Council has approved the allocation of £200,000 from the CIM Fund ring-fenced for Stogursey to Stogursey and District Village Hall Committee as a contribution towards the Victory Hall Project.
- (b) To release £400,000 from the CIM Fund ring-fenced for West Somerset to Stogursey and District Victory Hall Committee as a contribution towards the Victory Hall Project with the condition that no funding shall be released until:
  - The HPC Planning Obligations Board is presented with details of the governance and management arrangements for the project, including evidence of the skills and experience of the project team and the inclusion of skilled and experienced non-executive members within its structure, and is satisfied with those arrangements.
  - All other funding has been secured to cover the total costs of the project.
- (c) To refuse the application from the Community Council for Somerset for their Village Agents project on the basis that, at this time, the level of need for the project in relation to the HPC development in some areas cannot be established and that the applicant is encouraged to submit an application to the Community Impact Fund via the Somerset Community Foundation when this funding becomes available.

# C17 <u>HPC Planning Obligations Board – Allocation of Housing Contribution</u>

(Report No. WSC 63/16, circulated with the Agenda.)

The purpose of the report was to present the recommendations of the Hinkley Point C Planning Obligations Board for the allocation of monies from the Housing Contribution secured through the Section 106 legal agreement for the Site Preparation Works at Hinkley Point C.

The Lead Member for Resources and Central Support presented the report on behalf of the Lead Member for Housing, Health and Wellbeing and stated that one of the major challenges in the process had been looking at housing to increase bed spaces for local as well as external Hinkley workforce. She went on to provide details of what the funding would be used for and advised that the initiatives would help people, who did not have access to a bank account for example, to gain better access to housing accommodation more quickly and easily, in a more streamlined fashion.

She proposed the recommendation of the report which was duly seconded by Councillor J Parbrook.

During the discussion, clarification was provided on what areas the Credit Union covered and who would benefit.

**RESOLVED** that the recommendation of the Hinkley Point C Planning Obligation Board be endorsed as follows:

(a) To release £10,600 of the HPC Site Preparation Works Section 106 Housing Contribution to Bridgwater and District Credit Union for the upgrade of their systems and website.

## C18 <u>Hinkley Point C Housing Fund – Update and Changes to Governance Arrangements</u>

(Report No. WSC 64/16, circulated with the Agenda.)

The purpose of the report was to provide an update on the status of the Hinkley Point C Housing Fund which was paid to West Somerset Council in May 2014. It also sought approval for a change in the way in which the fund is governed.

The Lead Member for Housing, Health and Wellbeing presented the report and provided detailed background information. He advised that Sedgemoor District Council (SDC) felt the housing fund process needed to be shortened and had asked WSC to split the housing enabling fund to enable them to fund their own schemes as it was clear that Sedgemoor had different priorities to that of West Somerset. It was reported that a legal agreement had been drawn up for both councils which ensured that all responsibility of how SDC spent their monies fell to them and therefore there was no risk to WSC.

Points raised during the discussion included:

- Members were supportive and the Lead Member for Housing, Health and Wellbeing and the officers involved were thanked for their work in reaching an agreeable solution for both councils.
- It was a positive step for WSC as the Council could now guarantee that a portion of the fund was spent on projects in the district.
- A concern was raised that the funding as referred to in recommendation 2.3 of the report did not mention 'West Somerset'.
- A further concern was raised regarding recommendation 2.3 in that there did not appear to be any council scrutiny of the housing schemes - the mechanism should be robust and transparent and be consistent with the Council's financial regulations.
- Members were reassured that full Council had the power to amend and approve exceptions to the financial regulations in order to delegate additional responsibility as set out in recommendation 2.3.

The Lead Member proposed the recommendations of the report with a couple of additions to recommendation 2.3 to include the Leader of the Opposition in the list of Member delegations and to insert the words 'in West Somerset' following "....Housing Enabling Schemes....". The recommendations, as amended, were seconded by Councillor C Morgan.

**RESOLVED (1)** that the update in relation to the delivery of bed spaces in accordance with approved initiatives be noted.

**RESOLVED** (2) that the release of £1,759,272 to Sedgemoor District Council of the Hinkley Housing Fund be approved and authority be delegated to Sedgemoor District Council to spend this proportion of the contribution in accordance with the criteria set out in the Site Preparation Works Section 106 agreement provided that a legal agreement between the two District Councils is in place which ensures that all repayment risks for non-delivery of housing units using monies released to Sedgemoor District Council fall to Sedgemoor District Council prior to the release of funding.

RESOLVED (3) that authority be delegated to the Lead Member for Resources and Central Support, the Lead Member for Housing, Health and Wellbeing, Lead Member for Energy Infrastructure and the Leader of the Opposition alongside the Assistant Directors for Resources, Property and Development and Energy Infrastructure to invest the remaining £730,392 of the Hinkley Housing Fund in Housing Enabling Schemes in West Somerset in accordance with the criteria set out in the Site Preparation Works Section 106 agreement.

## C19 <u>Proposed Soundness Modifications to the West Somerset Local Plan</u> to 2032

(Report No. WSC 65/16, circulated with the Agenda. Appendix F and Appendix G circulated prior to the meeting.)

The purpose of the report was to put forward proposed soundness modifications to the West Somerset Local Plan to respond to substantive matters discussed at the hearing sessions.

The Lead Member for Housing, Health and Wellbeing presented the report and thanked the planning policy officers for the immense amount of work undertaken and their involvement in getting the Local Plan to this stage, which had spanned a 9 year period. He explained the consequences for the Council of not having a sound Local Plan in place, e.g. the loss of the New Homes Bonus, and advised the Local Plan was now consistent with the National Planning Policy Framework and had been adjusted as a result of the Examiner's comments during the hearing sessions. The Local Plan detailed alterations to the policy wording and these were clearly highlighted in the appendices to the report. The affordable housing policy had been subject to government change and as a consequence of a decision recently made, the policy would be reinstated to replace policy ref. SC4. Following public consultation and the Inspector's final assessment, it was envisaged that the Plan would be presented to full Council for adoption during August/September 2016.

He proposed the recommendations of the report, as amended, which were duly seconded by Councillor M Dewdney.
