CAB11 Rural Learning and Early Years Project(Sure Start) and Barle Enterprise Centre - Conclusion of matters

The purpose of the report was, following discussions with the Somerset County Council, to seek the endorsement of Cabinet of proposals to resolve the outstanding matters concerning the Sure Start Projects at Alcombe and Williton and the Barle Enterprise Centre.

RESOLVED (1) that Cabinet approve the payment of £294,531 to Somerset County Council in settlement of net sums owing by and owed to West Somerset Council in respect of the Sure Start projects at Alcombe and Williton.

RESOLVED (2) that Cabinet approve the withdrawal of West Somerset Council's interest in the Barle Enterprise Centre in accordance with the terms outlined in the report.
