5. Police Report

Inspector Simpson reported -

- There had been an increase in non-dwelling burglaries at one point up by 200%, but she emphasised actual numbers are small. The particular problem is that they are rural by nature. Other crime statistics are down.
- Traffic police are doing spot checks.
- Speeding on Priest Street figures showed that the vast majority of drivers were doing in excess of 30mph and therefore were prosecutable (over 50% driving in excess of 36mph).
- Youngsters/Drug related crime problems in Memorial Ground, Watchet concerning possible drug activity. Inspector Simpson explained that any information that members of the public have should be forwarded to the police.

7a. Quantock Hills AONB

lain Porter reported on the following:

- Illegal off-road vehicles driving on the hills. Natural England enforcement officers in conjunction with the police have made prosecutions.
- 46% of local government funding had been cut in recent years.
- Full programme of events volunteers welcome.

8. West Somerset Council

Adrian Dyer advised as follows:

- Attendees were reminded that there would be an Armed Forces Day Ceremony at the Council Offices on 25 June 2012 at 10.30am.
- Olympic Torch the passing of the torch through Williton proved a great success with particular thanks to Williton Parish Council for their assistance.
- Hinkley Point it was reported that there would be a delay in the commencement of the main preliminary works due to the wide-spread discovery of asbestos on the site which would require removal.
- Flood defence works following flooding in Dashwoods Lane, Bicknoller investigations have been carried out and a draft proposal is being put together to alleviate the possibility of future flooding.
- Goviers Lane railway crossing tender prices have been received and a meeting is scheduled to be held in July with WSR and SCC to discuss the allocation of costs.

Watchet Harbour

- A specification is being prepared to enable the work involved in demolishing the warehouse to be tendered.
- o Two treads have been replaced on the landing steps.
- The Council's Community Safety Officer is currently investigating an apparent conflict between anglers and boat owners when coming in and out of the harbour. Various measures were being considered including improved signage, the installation of steel bins for chopping and disposal of bait etc.
- Work has been undertaken to review the signage on the West Pier.
- Ongoing inspections of the impounding harbour wall is being undertaken by structural engineers as there are unproven claims that the wall is moving in high tides.

A question was raised as to the value that the Area Panel meetings were providing on the basis that there were no members of the public in attendance and if the district councillors and parish councillors were discounted then there were only five other people present. It was agreed to debate this issue further at the next meeting, and that a notice of meetings would be published in the Community Matters newsletter.

The Chairman of the Panel raised two issues concerning Williton Hospital and the free school status of Danesfield School. With regard to the hospital he advised that the redeployment of staff was complete and no members of staff had been made compulsory redundant. He further advised that future plans to maximise the opportunities at the hospital are being formulated but the outpatient facilities would remain as they currently are. With regard to Danesfield School he advised that the parents' attempt to obtain free school status was proving difficult in that sufficient overall support amongst parents was not forthcoming.
