RESOLVED that the recommendations contained in Section 1 of the Report be approved (in so far as they relate to the above), including, where appropriate, the conditions imposed and the reasons for refusal, subject to any amendments detailed below:

AGREED that a decision of APPROVAL be delegated to the Planning Manager to amend the schedule of conditions and reasons and to finalise the requirements of the Section 106 Agreement. SUBJECT ALSO to the inclusion of Condition 27 as contained in Late Correspondence and a Condition requiring a Construction Management Plan (Condition 28).

Condition 27

Prior to the work commencing on the development hereby approved, details for the access onto Parks Walk shall be submitted to and agreed in writing by the Local Planning Authority. The access shall be provided prior to the first occupation of any of the flats hereby approved and thereafter retained as such.

Reason: To provide an alternative pedestrian/ mobility scooter access into Minehead and for access to The Parks Walk and to comply with saved policy 49 of Somerset and Exmoor National Park Joint Structure Plan Review

Condition 28

No works shall be undertaken on site unless details of a construction management plan has been submitted to and approved in writing by the local planning authority. The management plan shall include details of hours of working, methods for minimizing noise and disturbance to nearby neighbours, the provision of on-site parking for workers and contractors and to ensure that all vehicles associated with the construction of the development are in a condition so that upon leaving the site the vehicles will not emit dust or deposit mud or other debris on the highway. The development shall be carried out in accordance with the approved construction management plan.

<u>Reason</u>: In the interests of the amenity of neighbouring residents and in the interests of highway safety having regard to the provisions of Saved Policies BD/2 and T/3 of the West Somerset District Local Plan (2006).
