P194 Town and Country Planning Act 1990 and Other Matters

The Committee considered the reports, prepared by the Planning Team, relating to plans deposited in accordance with the planning legislation and, where appropriate, Members were advised of correspondence received and subsequent amendments since the agenda had been prepared.

RESOLVED That the Recommendations contained in Section 1 of the Report be Approved (in so far as they relate to the above), including, where appropriate, the conditions imposed and the reasons for refusal, subject to any amendments detailed below:

Reference Location, Proposal, Debate and Decision

3/12/14/86 Land at Ellicombe Meadow, Minehead

Proposed residential development of eight semi-detached dwellings (plots 23, 23A, 24, 24A, 25, 25A, 26 & 26A) in place of four approved detached dwellings and a block of nine flats rather than an approved block of eight flats (plots 5 to 12A) together with vehicular parking, access and associated infrastructure (amended scheme to planning permission 3/21/13/084)

The Members debate centred on the following issues:

- Contradiction from the original planning permission
- Developers have not managed conditions in terms of traffic and timescales and will be a disruption to residents
- Types of housing do not meet the needs of the age group
- Developers need to obey existing conditions
- More useful housing required, not 3 storey.
- No faith in the developer, planning by stealth
- CIL instead of affordable housing

Councillor L Smith proposed and Councillor D Ross seconded a motion that planning permission be **Refused** for the reason below.

Reason:- The proposed 3 storey dwellings would be of a size and height that would have a detrimental impact on views into and from the National Park which would significantly and demonstrably outweigh the benefits of providing additional housing in Minehead. The proposal is therefore contrary to the provisions of the NPPF and policies BD/1, BD/2, LC/1 and LC/3 of the West Somerset District Local Plan (adopted 2006).

The motion was carried.

3/28/14/013 Crossways, Sampford Rocks, Sampford Brett

Erection of 4 bedroom detached house with detached garage

The Members debate centred on the following issues:

- Not visible going past on the road
- · Highways technically correct, not practical
- Is this compliance with the size of the garage
- Surface water issue

Councillor May proposed and Councillor Morgan seconded a motion that planning permission be **GRANTED** in accordance with the Officer's recommendation with an added condition regarding the surface water provision.

The motion was carried.

3/21/14/104 Harbour Wall, Quay Street, Minehead

The erection of a pavilion, demolition of part and re-ordering of the remaining existing changing facilities, MUGA, disable and service vehicle/pedestrian access from Robert Street and associated parking facilities

• Reference was made to ensure that the correct bolts were used to mount the plaque.

Councillor Ross proposed and Councillor K Mills seconded a motion that planning permission be **GRANTED** in accordance with the Officers recommendation.
