#### 101. Welcome

The Chairman welcomed everyone to the meeting – the second time the Planning Committee had met at the Blackbrook Pavilion Sports Centre, Blackbrook Way, Taunton to consider a major planning application.

#### 103. Declarations of Interest

Councillors M Adkins, Coles and Wedderkopp declared personal interests as Members of Somerset County Council. Councillor Townsend declared personal interests as Vice-Chairman of Kingston St Mary Parish Council and Chairman of the Kingston St Mary Village Hall Association. Councillor Wren declared a personal interest as he was Clerk to Milverton Parish Council. All Councillors declared that they had received correspondence from the following - Friends of Comeytrowe Park, CRAG Action Group, Master Plan from Barton Wilmot, emails from Steve Smith. Councillor Coles also declared that he had attended the Trull Parish Council public meeting that was held in Galmington at which he spoke but declared that he had not 'fettered his discretion'. Councillor Mrs Smith declared a personal interest as her daughter lived off Deane Drive. Councillor Brown declared that he knew a person in

the audience and several people that he worked for in Trull. Councillor Martin-Scott declared personal interests as a trustee to the Home Service Furniture Trust, trustee to Bishop Foxes Educational Foundation and a trustee to Trull Memorial Hall. He also declared that he had a personal and prejudicial interest following the receipt of officer advice and been told that his membership of the Trull Neighbourhood Plan Group and his Vice-Chairmanship of the Wilton and Sherford Community Association did not preclude him from taking part and voting on the planning matter about to be discussed.

104. Outline planning application with all matters reserved (except points of access) for a residential and mixed use urban extension at Comeytrowe/Trull to include up to 2000 dwellings, up to 5.25 hectares of employment land, 2.2 hectares of land for a Primary School, a mixed use local centre, and a 300 space 'park and bus' facility on land at Comeytrowe/Trull with an additional Section 106 clause relating to the need to set up a Design Working Group (42/14/0069)

Reported this application.

Following the receipt of many representations from local Parish Councils, Action Groups and members of the public, a lengthy discussions by the Planning Committee ensued. Towards the end of the debate, a proposal to defer the application was proposed and seconded.

**Resolved** that the application be **deferred** to allow sufficient time for the preparation of a comprehensive master plan by the applicants which:-

- Involved engagement with relevant stakeholders; and
- Placed particular (but not exclusive) emphasis on the issues of highways, education and health.
