4. Hinkley Point C Operational Draft Permits Consultation

Representatives from the Environment Agency gave a verbal report to the meeting concerning their involvement on the proposed construction of Hinkley Point C. No follow up action required.

5. Williton Surgery and Pharmacy

Lloyds Pharmacy were represented including the regional manager and local manager attended the meeting to answer questions concerning the poor service that people felt was being provided. They confirmed that there had been issues concerning the operation of the pharmacy in the past that had affected performance but that this had now be resolved. It was emphasised that it was vital the dispensing of drugs was carried out in accordance with legal requirements. No follow up action required.

6. Police Report

It was reported that detected crimes were at 42%, there were potential issues concerning non-dwelling burglaries and badger cull. A long debate took place concerning speeding in Tower Hill and the fact that vehicles often used Bridge Street as a short cut, which transgressed the one-way system. Action during the debate it

was agreed that SCC would send a resident living in Bridge Street an application for a disabled parking bay.
